Contract for Permission to Use or Publish Photographs

President and Fellows of Harvard College, Peabody Museum of Archaeology and Ethnology (hereinafter, "Peabody Museum - Harvard") supplies an image in the requested format for one-time use only and for the purpose listed in the attached, "Statement of Intended Use Form." Any additional use, such as on an end paper or dust jacket on a book or as any other advertisement constitutes a separate use and must be applied for in writing. Additionally, any subsequent edition reissue, translation, etc., in any medium constitutes reuse and must be applied for in writing. There is a reuse fee.

By signing below, the Requestor agrees to the following Terms and Conditions and Credit Guidelines:

Terms and Conditions

One complimentary copy of any published work, including CD-ROM products and links to webpages, in which the image appears, must be provided to the Office of Rights and Reproductions, Peabody Museum - Harvard.

Requester may not reproduce copies of the images nor grant other parties permission to create reproductions or facsimiles of the image, except that reproductions of the image may be made for on-line or paper course-pack materials containing all or a portion of Requester's work listed below, subject to Requestor's compliance with the other requirements of this contract.

Peabody Museum - Harvard does not grant Requester exclusive use through this contract and retains its rights to publish and/or grant permissions for others to do so.

Peabody Museum - Harvard reserves the right to limit the number of photographic copies; to restrict the use or reproduction of rare, valuable, or sensitive materials, to refuse permission for inappropriate uses; and to charge different fees from the ones published on its website.

This Agreement shall be governed by and interpreted in accordance with the laws of the Commonwealth of Massachusetts (excluding conflict of laws rules).

Unless expressly approved in advance by Peabody Museum - Harvard, images must be reproduced unaltered and in their entirety; images may not be cropped, overprinted, printed on color stock, or bleed off the page. No Image used by Licensee will exceed 1 mega pixel dimension (1600 × 1200 pixels) for web use.

Requestor acknowledges that the images and original objects depicted in the images may be protected by copyrights and other rights (including but not limited to artists' rights of attribution or control and rights of privacy or publicity) not owned by Peabody Museum - Harvard or Harvard. Peabody Museum - Harvard does not represent or warrant that it or Harvard owns all applicable copyright or other rights in the images or objects depicted in the images. The Museum does not purport to grant any right or license with respect to third party rights. The Requestor is solely responsible to ascertain whether any license or permission is required from any third party, and to secure any and all required permissions from copyright owners and other third parties, and to pay any fees as such parties may require. Requestor assumes all responsibility for matters of copyright, right of publicity, and invasion of privacy that may arise in copying and use of the images. Requestor agrees that in all instances, it will hold the Peabody Museum - Harvard and President and Fellows of Harvard College ("Harvard"), its officers, members of governing boards, agents and employees, harmless against any and all claims, costs (including attorneys'

fees and court costs), liabilities, losses or damages of any nature arising or resulting from the use of the images, and shall indemnify such parties for any and all claims, costs (including attorneys' fees and court costs), liabilities, losses and damages arising or resulting from any such use.

Peabody Museum - Harvard disclaims all warranties of any kinds (express, implied or otherwise) regarding the images or this agreement, including but not limited to, any implied warranties of merchantability, fitness for a particular purpose, ownership and non-infringement.

Except in accordance with the credit guidelines below, Requestor shall not use or register the name "Peabody Museum - Harvard", "Harvard" (alone or as part of another name) or any logos, seals, insignia or other words, names, symbols or devices that identify Peabody Museum - Harvard, Harvard or any Harvard school, unit, division or affiliate ("<u>Harvard Names</u>") for any purpose except with the prior written approval of, and in accordance with restrictions required by, Harvard. Any usage by the requestor is not endorsed or sponsored by Harvard Names, nor shall the requestor imply that any usage is endorsed or sponsored by Harvard Names.

Credit Guidelines

The following standard credit format must be utilized for each image or further permissions will be denied.

The Peabody Museum - Harvard reserves the right to require inclusion of additional credit information or copyright or other notices and to charge liquidated damages of \$10,000.00 for failure to comply with agreement guidelines. We ask that you comply with these guidelines and conditions:

Published Materials; the credit line should appear on the same or a separate photo credits page. Each individual image used must be credited properly.

Films, Filmstrips, and Video Presentations; include the credit within the "Sources for Illustrations/Images" or "Credits" section of the production.

Exhibitions; the credit should appear in the exhibition area, preferably directly below or adjacent to the original copy. **Web use**; the credit should appear either adjacent to the image or in a "Sources of Illustrations/Images" section. Digital images must include the full Peabody Museum number with the name of the digital file. The Uniform Resource Locator to http://www.peabody.harvard.edu/ (The Peabody Museum - Harvard's main web page) should also be included. No Image used by Licensee will exceed 1 mean pixel dimension (1600 x 1200 pixels) for web use.

iPhone or Android Applications (Aprs); the credit should appear either adjacent to the image or in a "Sources of Illustrations/Images" section. Dignal images must include the full negative number with the name of the digital file. No Image used by Licensee will exceed 1 mega pixel dimension (1600 x 1200 pixels).

eBook: the credit line should appear on the same or facing page as the image, or on a separate photo credits page. Each individual image used must be credited properly.

PowerPoint: the credit me should appear on the same slide as the image, or on a separate photo credits slide. Each individual image used must be credited properly.
